A. () I am eligible and elect to attend a **four (4) hour basic traffic course**, approved by the State of Florida pursuant to section 318.14(9) Florida Statutes. I have not elected a course within the past twelve (12) months, or five (5) times in my lifetime, I do not have a Commercial Driver License (CDL) and I was not driving a commercial vehicle at the time of the citation. I understand that non-compliance will result in the suspension of my driving privileges, assessment of points and additional costs of \$41.00.

B. () I am eligible and elect to attend the **Child Restraint Offenders Program**, pursuant to Administrative Order No. 2008-02. I have not elected a course within the past twelve (12) months, or five (5) times in my lifetime and I do not have a Commercial Driver License (CDL) and I was not driving a commercial vehicle at the time of the citation. Further, I understand that non-compliance will result in the suspension of my driving privileges, assessment of points, a fine of \$163.00, plus a late charge fee of \$23.00 and penalty fee of \$18.00, totaling \$204.00 and all previously paid costs will be forfeited.

I, the undersigned, do solemnly swear or affirm, subject to the penalty of perjury and possible contempt of court that I am eligible for the option checked above. I am pleading no contest to the charge. I have 60 days to attend the school elected and turn in the original school completion certificate to the Martin County Clerk of the Circuit Court, Traffic Division.
